IMPORTANT, PLEASE NOTE:

Dancers must be age 11 by September 1st to qualify for an ORB position.

As a Communities Outreach effort to inform, educate and expose local school students to the Art of Ballet, ORB holds two abbreviated performances each Friday of performance weeks. <u>Dancers will be missing a day of school for each performance venue</u>. (2-4 days in total)

With this application submission, you give ORB the right to videotape this audition for judging reference.

Rehearsals will begin in August on Fridays, Saturdays, and /or Sundays. The actual schedule will be made available once all audition selections have been made. Please be honest about your priorities above.

A preliminary orientation meeting will be <u>required</u> for parents and dancers, and is being considered for a Sunday in July. (Date forthcoming)

If an additional audition for principal parts must take place, dancers will be notified after their acceptance into ORB.

AUDITION INSTRUCTIONS

If a dancer is unable to attend ORB open auditions, they may instead submit a video audition.

Please download and fill out the Oil Region Ballet Company audition form found online at oilregionballet.org.

AUDITION REQUIREMENTS

Annual open auditions are held each Spring in two locations offering limited available positions for Corps de Ballet, ages 13 & up, and Petite Apprentice positions, ages 11 (by September 1st) -13. Times and dates are posted on the website, social media and in ORB performance programs. Auditions include a ballet technique class, followed by center pointe work and gentlemen's exercises.

VIDEO AUDITION REQUIREMENTS

Recordings should be high quality video of the dancer alone, no more than 20 minutes in length. The segment should show adagio, petit allegro, allegro, pirouettes, pique turns and entrechats. Female applicants please include at least two combinations en pointe at barre and center. Also include a dance resume if applicable with a completed ORB audition application and photographs in first arabesque and a head shot. No recorded audition can be considered after August 1st.



RELEASE OF ACCIDENT CLAIMS 2025/26 SEASON

The undersigned Participant and the Participant's parent or legal guardian represent that they are fully aware and apprised that there are risks and physical demands inherent to the physical activities involved in dance, tumbling, dance performance and dance/tumbling training. In the event of any emergency, Participant and Guardian authorize the Oil Region Ballet Company officials or instructors to secure from any licensed hospital, physician and/or medical personnel any treatment deemed necessary for Participant's immediate care.

Participant and Guardian acknowledge that Oil Region Ballet Company DOES NOT provide insurance for injuries suffered in connection with dance or tumbling activities and that it is the responsibility of the Participant and Guardian to obtain adequate insurance coverage to cover the Participant's risk of injury.
